The competition for the sixteen AFJROTC Academic Bowl spots was tough, but your team proved their academic abilities. Your cadets are going to have the experience of a lifetime!

As you begin preparing for your trip, here are a few details....

- 1. **Dates** June 21-25, 2024 Teams should plan to arrive on Friday, June 21 no later than 5 PM in time for dinner and the Opening Ceremony and depart no later than 10 AM on Tuesday, June 25. There are no activities planned on June 25.
- 2. **Press Coverage -** We would like to receive some media coverage about your smart, dedicated cadets. Attached is a press release announcing your team's advancement to the Championship. Please use the attached customizable press release to send to your local news outlets announcing your unit's accomplishment and share the coverage with us (email copies of press coverage to lconway@collegeoptions.net). You may consider working with press officers in your school district to draft and distribute the press release.
- 3. **Team Participation** Each team is authorized to bring the four primary team members, one instructor, and one female chaperone (if required by your school/district). The team coach/instructor is permitted to substitute cadets if an original team member is not available to attend JLAB. Female staff members are available on campus with your female cadets through the duration of the event; however, if you are required by your school to travel with a female chaperone, you will be able to add her information during online registration. Unfortunately, **alternates cannot be accommodated at JLAB 2024** due to space limitations (as outlined in the original guidelines of the competition). In addition, space for spectators is limited to instructors/chaperones due to COVID mitigation protocols.
- 4. **Travel, Meals, Lodging, and Competition Costs** Air Force JROTC HQ covers all competition costs (lodging and meals) and most travel costs for AFJROTC teams attending the Championship event. You will indicate your travel preferences during registration (air, train, car, etc.). Please review the attached Travel Info document for more details.
- 5. **Lodging** Cadets and their instructors will stay in dorms on the campus of The Catholic University of America. Instructors and chaperones will have individual rooms in the same or nearby dorms and share bathrooms and common spaces with other adults. Two four cadets will share a room and common bathroom facilities. Males and females (including adults) will be accommodated in separate buildings on campus.

6. **Registration** – Registration for JLAB will be held March 1-31 through your instructor dashboard on www.cofcontests.com.

- 7. Competition In the competition, all four team members participate as a group in a college bowl-type game with buzzers. Questions will be very similar to those found in the online game; more specific information on the content will be forwarded shortly. A practice round will be held on Friday evening after the Opening Ceremony so that all teams will have an opportunity to practice with the game buzzers and review the rules. After preliminary rounds on Saturday, the AFJROTC Academic Bowl Championship will be held on Sunday at 12:30 PM. The Joint Service Academic Bowl will be held on Sunday afternoon immediately following the Army Academic Championship (approximately 5 PM on Sunday). The winning team from the Air Force will compete against the winning teams from the Army, Navy, and Marine Corps JROTC Academic Championships in a four-way competition. Monday is reserved for sightseeing; the Awards Ceremony will be held Monday night. NOTE: The Championships and other evening programs will be livestreamed so that families and other members of the unit may watch.

Many more details about the Academic Championship will be sent in the upcoming weeks, including how to prepare for the competition. Correspondence is primarily through email so please check your email regularly for updates and suspense deadlines. In addition, all documents are available on your dashboard under *Resources* after logging in to www.cofcontests.com.

## JROTC Leadership & Academic Bowl National Championship Health & Safety Guidelines

(Updated 15 Feb 2024)

College Options Foundation and the U.S. JROTC Commands take your safety seriously. Below you will find the health and safety initiatives we are taking to ensure JLAB 2024 is safe and fun!

#### **KEY POINTS**

- Every attendee must review this website prior to travel <u>Washington, DC COVID-19</u> Travel Updates Travel Status Update | Washington DC
- Washington, DC requirements: As of Oct. 2022, the DC government has eliminated mask and vaccine requirements for visitors. However, masks may be required in some indoor spaces such as museums. We will update all attendees on any changes prior to JLAB.

#### Prior to traveling to DC (by air or car)

- Be mindful of group activities within 14 days of travel to DC. Avoid crowds and/or people who have experienced symptoms or tested positive for COVID-19 or other viruses.
- Monitor yourself for symptoms of illness.
- Travelers who believe they may have been in contact with a person who has COVID-19 should consult with their healthcare provider prior to departure. Travelers who have tested positive for COVID-19 should seek medical attention and follow the guidance of their healthcare provider and local health department. \*Anyone who tests positive or is experiencing symptoms should NOT attend JLAB!

#### While traveling via Airplane or Train

- Airline and train travelers may wear a face mask throughout the travel experience; however, masks are no longer required.
- Travelers are also encouraged to:
  - Maintain a social distance of six feet wherever possible, especially when standing in lines.
  - Wash your hands regularly, including directly before and after completing the security screening process. If it is not possible to wash your hands, please use hand sanitizer.

#### Once at JLAB 2024

- We will have dedicated full-time staff members whose role is to assist in protocol observations and monitoring.
- Currently, face coverings are not required for attendees.
- We will have a limited number of guests (Command staff and speakers only).
- Monitor temperatures and questions concerning exposure or symptoms of any illness prior to attending the event and continuously throughout the event.
- Wash hands frequently and/or use hand sanitizer stations available throughout event.
- Require personal responsibility statements by all attendees.



- COF will have an operational plan in the event of identified infected person(s).
- Limited group size and additional spacing during events.

# Bedford High School Air Force JROTC Team Secures Place in National Academic Bowl Championship in Washington, DC

#### **JLAB 2024 Travel Information**

Congratulations to your cadets for earning the opportunity to attend JLAB in Washington, DC!

#### STEPS TO PLAN YOUR TRAVEL TO JLAB:

- 1. Review the travel options in this document carefully.
- 2. During online registration (March 1-31), you will provide your preferences (type of transportation, departure date/time, etc.). You will need the full name (as it appears on ID including middle name or initial if applicable) and birthdate of ALL travelers by plane or train. Please have all of this information ready when you register.
- 3. If you choose to travel by plane or train, you will receive further instructions with specific information via email.
- 4. If you choose to travel via automobile (rental, school vehicle, or POV), you will receive further instructions via email.
- 5. Do NOT purchase any tickets. COF will purchase tickets for transportation for the Army, Air Force, and Marine Corps teams. The only exception are the Navy and Coast Guard Academic Teams who will receive further instructions from their HQs to arrange travel to JLAB.

This document contains important information regarding your travel to Washington this summer. Please read it carefully and refer back to it if needed. If you have been to JLAB before, please take note that there are several changes in the travel procedure from previous years. As always, we try to improve our service year to year.

College Options Foundation will arrange your transportation to/from the event (excluding the Navy and Coast Guard teams — see #5 above). Army Leadership Teams must arrive in DC no later than 5:00 pm on Sunday, June 16 and depart on Thursday, June 20. All Academic Teams must arrive in DC no later than 5:00 pm on Friday, June 21 and depart on Tuesday, June 25.

The options for travel include driving (rental, school vehicle, or POV), taking the train, or flying.

In an effort to reduce the enormous travel costs associated with the event, we encourage those teams within a 400-mile radius of Washington, DC to drive.

#### **Options for JLAB travel**

Determine your preferred mode of travel (auto, train, air). You will indicate this during the registration process, March 1-31.

#### 1. Travel by Car

- If you plan to drive, you may rent a vehicle, use your POV, or drive a school vehicle. If you are renting a car to drive to DC, you will receive a flyer with an event code and link for making your reservation will be provided. You do not need to provide your personal credit card. **NOTE:** The link on the flyer is only if you are renting a vehicle to drive to DC, not to rent upon arrival in DC. All in and around transportation during JLAB is provided. Rental vehicles are not approved for teams flying to Washington, DC.
- Mileage reimbursement for use of your POV will be the standard government rate of 65.5 cents per mile.
- Instructions for parking will be provided at a later date.

#### 2. Travel by Plane or Train

Please be aware that once an airline or train ticket has been purchased, if the reservation is changed or canceled, the funds may be forfeited. If a new ticket needs to be purchased, it will be at the team's expense. Please make sure that all team members are available and committed to attend JLAB before registering. A change in your itinerary, whether it is a schedule change or a passenger change, can be very costly and will be done at your expense.

- You will be contacted by the travel coordinator (Laura Hadley) to complete the process of confirming airline reservations for your team.
- Travelers 18 years old and older are required to show government issued identification at the airport when going through TSA.
- Please check-in online 24 hours in advance of your flight. On most airlines, you can check-in online and pay for your checked bags at that time (2 bags per team will be paid for by COF).
- Refer to the airline website and the JLAB Covid Mitigation Protocols for information on travel precautions.
- More information regarding ground transportation in DC from the airport to the Catholic University will be provided.
