# **November 9, 2021**

## Live Virtual Online Meeting using ZOOM Audio/Video Conference Software

\*\* Due to the COVID-19 Crisis, this meeting was live-streamed over the internet using ZOOM video/audio conferencing software in order to adhere with social distancing measures put in place by Governor Baker. This meeting was open to the public for live chat during Public Comment.

#### 1. Call to Order

At 7:03 PM, Ms. Scoville called to order the meeting of the Bedford School Committee. Other members present included Ms. Guay, Ms. Santiago, Mr. Brosgol, Mr. Morrison, Student Representative Prakhar Gupta

# 2. Public Comment

# 3. Acknowledgement of Bedford Board of Health Letter

Ms. Scoville read, acknowledged and thanked the Bedford Board of Health for writing a letter to the School Committee with regards to recommending the implementation of the COVID-19 vaccination mandate for all staff working in the district. Ms. Scoville further shared that the district is continuing to collect data on everyone that works in the school building. Collaborative work continues to be done so to make a final decision.

# 4. BHS Musicals

Ms. Nicole O'Toole and Ms. Katrina Faulstich along with student performers Connor McClung, Mary Couvee, Cate Galante and Ben Couvee spoke about the two musicals that the BHS performing arts program will be presenting this year. The first performance will be "The Drowsy Chaperone", which will be held November 18-20th followed by "Mama Mia" in March. These performances will be the first in front of a live audience since COVID-19 started. The students all spoke with excitement and enthusiasm about returning to the stage to perform in front of a live audience. The students also spoke about the commitment it takes to any one production but that it was well worth it. Ms. Faulstich shared a short clip of the rehearsals for "The Drowsy Chaperone".

### 5. Shawsheen Tech Presentation-Brad Johnson

Mr. Brad Johnson, Superintendent at Shawsheen Tech presented to the School Committee a presentation about the many aspects offered at Shawsheen Tech. Mr. Johnson spoke about the relationship Shawsheen has with Bedford. It was also explained that some students can take and receive college credits through Middlesex Community College through concurrent enrollment. Mr. Johnson also spoke about the hands on experience students receive through the shop portion of the curriculum in addition to older student participating in CO-OP to enhance and expand their knowledge in their chosen area of study. Mr. Johnson also spoke about the similarities in a traditional high school and the differences a vocational curriculum provides to students.

#### 6. MCAS Presentation

Dr. Clifford presented MCAS results to the School Committee. Dr. Clifford presented an overview of the results. Dr. Clifford stated that statewide results showed that many students had gaps in Math knowledge and to a lesser extent, English language arts, as compared to students in the same grade before COVID-19 pandemic with fewer students meeting or exceeding grade level expectations. Students in grades 3-8 went down 16 points in Math, while students in 10<sup>th</sup> grade went down 7 points from 2019 vs 2021 MCAS. In ELA students on grades 3-8 dropped 6 points while students in 10<sup>th</sup> grade increased by 3 points from the 2019-2021 MCAS. DESE will not issue updated district and school accountability determinations for the Fall of 2021. The 2022 accountability targets and lowest performing student groups data will not be made available soon. Some of the changes that were made during the Spring of 2021 administration of the MCAS are as follows:

- Competency Determination
  - Class of 2022 was awarded a competency modification in ELA and math upon district certification that students earned full credit for relevant courses in that subject mater
- Participation Rates
  - Statewide participation remained high in 2021 with the focus on utilizing the results for diagnostic and improvement purposes.
  - Students taking a test remotely had to have a similar test to those students that took the test in-person
- MCAS Sessions were given as one section and not two in grades 3-8
- Students in the Class of 2023 are required to earn a passing MCAS in ELA and math in order to
  meet the state graduation requirements. Students in this class did not take the STE MCAS as
  they can earn a modified CD in Science by taking a full credit STE class.
- New for the 2021-2022 school year- Students in 6th grade will have a double block of reading and writing
- Math at Davis and Lane will have a targeted tiered intervention with support of Title I

# 7. Top Level FY23 Budget Presentation

Mr. Conrad presented the following to the School Committee regarding the FY23 Budget. Mr. Conrad did preface his presentation by saying it was very early in the planning stages for the budget and that what he was presenting were talking points as to what is going to possibly be needed. A final budget will not be finalized until early March. The following are some of the areas being discussed for this budget process.

- Adhere to the 3.5% budget guideline
  - Reduce COVID-related expenses
  - Align with district goals
  - Create student-centered budget
  - Meet all contractual obligations
- Identify Unmet student needs
  - Assess K-12 class size/caseloads
  - O Capitalize on opportunities for efficiency/consolidate
- Things driving the budget
  - Contractual increases

- Investment in Social Emotional Learning, Diversity, Equity and Inclusion
- Literacy
- Additional needs
  - Preschools need for additional space for mandated services
  - Grant-funded part-time Reading Teacher-Davis
  - Part-time floater nurse due to caseload
