3. Contract negotiations

Mr. Sills updated the School Committee on the contract negotiations with the BEA and shared that the union voted to approve the contract earlier in the day.

Ms. Santiago asked clarifying questions regarding steps and lanes.

Mr. McAllister asked Mr. Coelho to provide additional details about other towns COLA increases in recent negotiations with teachers' unions and overall increases as they relate to the COLA increase.

Mr. Coelho shared figures from Swampscott (1%, 1%, 1.5% for a 10.03% increase over the 3 years), Burlington (2%, 2%, 2% for a 15.5% increase), Needham (1.5%, 2%, 2.25% and 14.86% overall), and Wayland (2%, 2.25%, 2.25% and 10.57%).

Mr. Coelho also shared that if goal was a 10% increase over 3 years in the current negotiations, then the COLA increases would have had to be 1%, 1%, and 1.5%.

Mr. McAllister shared his perspective on the longevity bonuses as opposed to adding additional steps.

Mr. Reed provided some context about longevity bonuses being taken out of other collective bargaining agreements in the town but that came along with higher COLA increases.

Mr. Sills shared that the original COLA increases proposed by the BEA were 4%, 5%, and 4%.

Ms. Guay made the following motion.
